Demski reports that the new location, previously a manufacturing facility, needs very few modifications -- one of the many attributes that attracted Globus to the site. The premiere, one-story structure is already in immaculate condition, fully heated and air-conditioned, and includes a finished suite of offices and ample paved parking.

"The purchase of our new headquarters makes complete sense from every possible angle," adds Demski. "It's reflective of our utilitarian personality, and completely consistent with our highly practical approach to doing business. It's a perfect fit."

The company plans to move to its new headquarters, located at 2560 General Armistead Boulevard in the Valley Forge Business Center, in mid-summer.
